Equality & Diversity Policy

1. Introduction

- i. Burton upon Stather Parish Council is an equal opportunities employer. We are committed to equality of opportunity and to providing a service and following practices which are free from unfair and unlawful discrimination. The aim of this policy is to ensure that no applicant, member of staff or Councillor receives less favourable treatment on the grounds of age, disability, gender reassignment, marriage and civil partnership, pregnancy or maternity, race religion or belief, sex or sexual orientation, or is disadvantaged by conditions or requirements which cannot be shown to be relevant to performance. It seeks also to ensure that no person is victimised or subjected to any form of bullying or harassment.
- ii. We value people as individuals with diverse opinions, cultures, lifestyles and circumstances. All employees, Councillors of Burton upon Stather Parish Council, volunteers and contractors are covered by this policy.
- iii. With regards to staff, this policy applies to all areas of employment including recruitment, selection, training, deployment, career development and promotion. With regards to Councillors, it applies to recruitment, selection and training. These areas are monitored and policies and practices are amended if necessary to ensure that no unfair or unlawful discrimination, intentional, unintentional, direct or indirect, overt or latent exists.
- iv. The Clerk has responsibility for implementing and monitoring the Equality and Diversity Policy and as part of this process, all personnel policies and procedures are administered with the objective of promoting equality of opportunity and eliminating unfair or unlawful discrimination.
- v. All employees, Councillors, volunteers, workers or self-employed contractors whether part-time, full-time or temporary will be treated fairly and with respect. Selection for employment, promotion, training or any other benefit will be based on aptitude and ability. All employees will be helped and encouraged to develop their full potential and the talents and resources of the workforce will be fully utilised to maximise the efficiency of the Parish Council.
- vi. Equality of opportunity, valuing diversity and compliance with the law is to the benefit of all individuals in the Parish Council as it seeks to develop the skills and abilities of its people. While specific responsibility for eliminating discrimination and providing equality of opportunity lies with the Council, individuals at all levels have a responsibility to treat others with dignity and respect. The personal commitment of all involved with the Parish Council, to this policy and application of principles are essential to eliminate discrimination and provide equality throughout the Parish Council

2. Our Commitment as an employer

- i. To create an environment in which individual differences and the contributions of our staff are recognised and valued.

- ii. Every employee, worker or self-employed contractor is entitled to a working environment that promotes dignity and respect to all. No form of intimidation, bullying or harassment will be tolerated.
- iii. Training, development and progression opportunities are available to all staff.
- iv. Equality in the workplace is good management practice and makes sound business sense.
- v. We will review all our employment practices and procedures to ensure fairness

3. Our Commitment as a Service Provider

- i. We aim to provide services to which all clients are entitled regardless of age, disability, gender reassignment, marriage and civil partnership, pregnancy or maternity, race, religion or belief, sex or sexual orientation, offending past, caring responsibilities or social class.
- ii. We will make sure that our services are delivered equitably and meet the diverse needs of our service users and clients by assessing and meeting the diverse needs of our clients.
- iii. We have clear procedures that enable our clients, candidates for jobs, employees and councillors to raise a grievance or make a complaint if they feel they have been unfairly treated.
- iv. Breaches of our equality and diversity policy will be regarded as misconduct and could lead to disciplinary proceedings.

4. Equal Opportunity Policy Statements

AGE

We will:

- a) Ensure that people of all ages are treated with respect and dignity;
- b) Ensure that people of working age are given equal access to our employment, training, development and promotion opportunities; and
- c) Challenge discriminatory assumptions about younger and older people.

DISABILITY

We will:

- a) Provide any reasonable adjustments to ensure disabled people have access to our services and employment opportunities;
- b) Challenge discriminatory assumptions about disabled people; and
- c) Seek to continue to improve access to information where possible eg alternative formatting.

RACE

We will:

- a) Challenge racism wherever it occurs;
- b) Respond swiftly and sensitively to racist incidents; and
- c) Actively promote race equality in the Parish Council

GENDER

We will:

- a) Challenge discriminatory assumptions about women and men;
- b) Take positive action to redress the negative effects of discrimination against women and men;

- c) Offer equal access for women and men to representation, services, employment, training and pay and encourage other organisations to do the same; and
- d) Provide support to prevent discrimination against transsexual people who have or who are about to undergo gender reassignment.

SEXUAL ORIENTATION

We will:

- a) Ensure that we take account of the needs of lesbians and gay men; and
- b) Promote positive images of lesbians, gay men and bisexuals.

RELIGION OR BELIEF

We will:

- a) Ensure that employees' religion or beliefs and related observances are respected and accommodated wherever possible; and
- b) Respect people's beliefs where the expression of those beliefs does not impinge on the legitimate rights of others.

PREGNANCY OR MATERNITY

We will:

- a) Ensure that people are treated with respect and dignity and that a positive image is promoted regardless of pregnancy or maternity;
- b) Challenge discriminatory assumptions about the pregnancy or maternity of our employees; and
- c) Ensure that no individual is disadvantaged and that we take account of the needs of our employees' pregnancy or maternity.

MARRIAGE OR CIVIL PARTNERSHIP

We will:

- a) Ensure that people are treated with respect and dignity and that a positive image is promoted regardless of marriage or civil partnership;
- b) Challenge discriminatory assumptions about the marriage or civil partnership of our employees; and
- c) Ensure that no individual is disadvantaged and that we take account of the needs of our employees' marriage or civil partnership.

EX-OFFENDERS

We will:

- a) Prevent discrimination against our employees regardless of their offending background (except where there is a known risk to children or vulnerable adults).

EQUAL PAY

We will:

- a) Ensure that all employees, male or female, have the right to the same contractual pay and benefits for carrying out the same work, work rated as equivalent work or work of equal value
